6. General Business

6.1 Kindergarten to School transition

Darlene Leach and Gina Suntesic, Early Learning Unit, Early Years and Primary Reform Division, Department of Education and Training

D Leach had an electronic presentation, with copies handed out to the committee.

Reference to acknowledgment of country as can be found in the internal cover of the 2016 Victorian Early Years Learning and Development Framework was made.

The VEYLDF document was introduced and discussion around the revised edition being based on new evidence from the last 10 years. Copies of the document can be ordered from the DET website. A handout of 'The Ecological Model' (adapted from Bronfenbrenner's 1979) was distributed to the committee as mentioned in the VEYLDF,

D Leach discussed the transitions between stages of learning and the continuity of learning and development from birth to adulthood. There was discussion around the transition process from kindergarten to prep and how schools and early years staff can work together in this process.

6.2 Best Start

Leigh Cruickshank, Coordinator Early Years Partnership, Melton City Council

The Best Start Short term outcome feedback plan is being finalised and will be sent to the Committee following the Vulnerable Children working group meeting on Monday 1 May 2017.

Plan Do Study Act cycles are underway with feedback to be provided at the next Vulnerable children working group meeting. It will take time to build the capacity of professionals to utilise this model of improvement. At the practitioner level, time away from direct service is a barrier to expanding the number of PDSAs being undertaken.

Patchwork session was held on March 21 and follow up consultation is being carried out with the legal department to confirm Councils' responsibilities for this program prior to progressing.

The Terms of Reference for the Partnership will be reviewed in line with the Best Start Policy and guideline requirements that have been included in a template from DET.

6.3 DET update

Fiona Norman, Early Childhood Performance and Planning Advisor SWV Region Brimbank/Melton, DET

F Norman discussed the Maternal and Child Health statewide conference which had a prenatal and mental health focus.

Funding increases to MCH will provide additional outreach, extending enhanced maternal child and health to three years of age, bicultural workers in enhanced teams (this is dependent on the demographics of the municipality), scholarships for nurses, and increasing staffing on the MCH line. Additional funding for playgroups will enable each municipality to have the supported playgroup program.

Applications are open for the 2017-18 Children's Facilities Capital Program Minor Grants round.

F Norman discussed the pre-purchased places for kindergarten professional development day, a collective training opportunity across the sector. There was a focus on trauma, vulnerable children and families, and practical strategies and tools for communicating with families.



F Norman provided an update on the Brimbank Melton Early Years Lookout Advisor position with a focus on Out of Home Care across the SWV Region.

The closing date for the Early Years Awards nominations is 15 May.
