## 6.1 Purpose of the Partnership

### 6.3 CALD community - Essan Dileri, MCC Intercultural Development Officer

Speaker, Essan Dileri, Intercultural Development Officer, Melton City Council.

- Essan provided an electronic presentation discussing the dynamics of culture and terminology around this, including acculturation and enculturation.
- G Sawczyn DHHS asked how Melton City Council is incorporating interculturalism. Essan provided that there is a four-year intercultural plan.
- P Schwartz mentioned the difficulties in schools and how the absence of a language school in Melton would benefit. Essan invited data to be forwarded to him to assist in advocacy around this issue.
- D Hardy stated that special need families also make up 'culture'.

### 6.4 Best Start and MEYP update

Speaker, Leigh Cruickshank, Coordinator Early Years Partnership, Melton City Council.

- An update on the Vulnerable Children's Working Group was provided and how services are developing PDSA (Plan-Do-Study-Act) cycles.
- The Municipal Early Years Plan (MEYP) evaluation needs to take place, with the development of a new plan occurring in the second part of the year. The MEYP is the strategic plan for children aged 0-12 years and combines data, feedback from families, children and services into a plan to improve outcomes for children in the municipality.
- Discussion was held around how the evaluation will take place. Leigh informed the committee that this would include completion of the endorsed evaluation framework. It will include parent carer surveys which will measure progress against benchmark of data from previous years.
- Leigh explained Council's responsibility for the development of the MEYP, how the document belongs to everyone and the ways service providers can participate in this process.

## 6.5 DET update

- DET, DHHS and local government are in the draft stage of the development of an Early Years Compact which will define how the three can work together regardless of who is in government at the time.
- There is a new office in Keilor for Brimbank/Melton. Local area staff will be based in the community they work with.
- The National Disability Insurance Scheme was discussed. S Ramsey raised concerns about the scheme. Fiona acknowledged these concerns and explained that her scope only included the early years.
- "Look Out' a virtual education support centre established for school aged children in Out of Home Care is moving into the early years space and are currently recruiting for an early years advisor.

## 6.6 DHHS update

Speaker, Genia Sawczyn, Senior Community Participation Officer, DHHS

- An update on Taskforce 1000 working group was provided.
- Family violence prevention grants and funding was discussed.
- · Roadmap to reform update will occur later in the year.

### 6.7 Assessment for Learning project, report from participants

Speakers, Andrew Comley, Assistant Principal, Kororoit Creek Primary School and Early Years Leader, Kororoit Creek Kindergarten and Christine Allen, Group and Education Leader, Goodstart Early Learning, West Melton.

- The Assessment for Learning project's purpose was to establish an inquiry into assessment practices in the early years. There was generally very positive feedback about the project from participants who formed a facilitated multidisciplinary professional development group who met regularly over a period of 9 months
- Andrew and Christine each discussed their participation in the project from different perspectives including how assessment tools are being used and their effectiveness.
- Written feedback on the project was provided by Deanna Patti, speech pathologist from Djerriwarrh Health Services who was unable to attend the meeting.
