Thank you for your letter regarding your concerns about the industrial dispute at Carlton and United Breweries last year.

The Victorian Government believes that all workers should have access to secure employment and decent working conditions. The Victorian Government established an independent Inquiry into Labour Hire and Insecure work to examine the social impact of insecure work and assess if the current legal framework meets the needs of workers. The Inquiry covers issues relevant to the situation at Carlton and United Breweries. The final report can be found at: http://economicdevelopment.vic.gov.au/inquiry-into-the-labour-hire-industry.

In response to the Inquiry, the Victorian Government has committed to establishing a labour hire licensing scheme to ensure strict oversight of labour hire companies. A full response to the Inquiry's 35 recommendations will be delivered in 2017.


