

Over 5,000 homes and businesses will change addresses, and while most will continue to have the same postcodes, three of the new suburbs, Aintree, Deanside and Fraser Rise, will have a new postcode, 3336.

Emergency services (police, SES, fire services and ambulance) and other government agencies, including water authorities, will be updated with the new addresses.

We're growing really quickly! Welcoming the new suburbs means that Council can create smaller, character-filled neighbourhoods that are easy to find and navigate. They'll have their own particular landmarks and will remain as unique and diverse as the people who live there.
