## 1. OPENING OF THE MEETING

The Chief Executive Officer, Mr Kelvin Tori, declared the meeting open.

### 6. ALTERATION OF THE GOVERNANCE RULES FOR THE ELECTION OF THE MAYOR AND, IF DETERMINED, THE DEPUTY MAYOR

The Chief Executive Officer advised Council that due to the meeting being held via a videoconference rather than in person, that nomination forms for the election of the Mayor and Deputy Mayor cannot be handed up as required by the Governance Rules.

That being the case, the Chief Executive Officer invited Council to move a Procedural Motion to suspend its Governance Rules.

### 7. ELECTION OF MAYOR

The Chief Executive Officer called for nominations for the office of Mayor.

Cr Majdlik was nominated by Cr Kesic.

The Chief Executive Officer, Mr Kelvin Tori, called for a seconder for this nomination.

Cr Majdlik's nomination was seconded by Cr Carli.

The Chief Executive Officer asked **Cr Majdlik** if she accepts the nomination and **Cr Majdlik** confirmed that she does.

The Chief Executive Officer called for further nominations for the office of Mayor.

There being no further nominations, the Chief Executive Officer declared **Cr Majdlik** elected as Mayor of the City of Melton for the 2020/21 municipal year.

### 9. ELECTION OF DEPUTY MAYOR, IF REQUIRED

The Mayor called for nominations for the office of Deputy Mayor.

Cr Kesic was nominated by the Mayor, Cr Majdlik.

The Mayor called for a seconder for this nomination.

Cr Kesic' nomination was seconded by Cr Shannon

The Mayor asked Cr Kesic if he accepts the nomination and Cr Kesic confirmed that he does.

The Mayor called for further nominations for the office of Deputy Mayor.

There being no further nominations, the Mayor declared **Cr Kesic** elected as Deputy Mayor of the City of Melton for the 2020/21 municipal year.
