8. African Communities Working Group (ACWG)

No meeting of the ACWG was scheduled between IAC meetings held in October and November 2019.

9. Holmesglen New Enterprise Incentive Scheme (NEIS)

Stephen Godfrey, from Holmesglen NEIS Program, presented on NEIS which assists eligible job seekers to kick-start their business venture by providing access, training in small business management and business advice and five business mentor sessions, all at no cost to participants. If the participants meet eligibility criteria they will further receive 9 months of NEIS income support, 6 months of rental assistance.

Holmesglen has been actively involved in providing NEIS training and support for over 20 years and offers training in Victoria and other states. The training will cover the following subject areas:

- Business planning
- Market research
- Financial planning
- Legal and taxation requirements
- Marketing and social media
- Business protection and insurance
- Advertising and promotion
- Bookkeeping

E Dileri asked if people seeking asylum could be part of the NIES. D Alurkar asked if young mothers or people on partner sponsored visas could be part of the program. Stephen responded any person with Australian work rights could be part of NIES program.

10. Headspace Presentation

Luke Hartley from Headspace presented on their services. Headspace centres act as a onestop-shop for young people who need help with mental health, physical health (including sexual health), alcohol and other drugs or work and study support.

Melton Headspace services are designed to ensure they are relevant, accessible and highly effective. At the heart of headspace centres is ensuring young people can access expert health workers in a safe, confidential and youth-friendly environment.

Melton Headspace services are free (or low cost) and provide support for:

- Mental health. Clinical mental health professionals are available to provide support, treatment and management plans for a variety of mental health concerns.
- Physical and sexual health. Many centres have on-site GP's who provide young people with a safe, confidential and judgement-free place to seek medical advice and treatment.
- Alcohol and other drugs. From providing information to treating addiction, alcohol and drug counsellors are available to address the complexities of alcohol and drug issues.
- Work and study. Counsellors and vocational workers are available to assist with a range of life skills, such as: managing workloads, dealing with stress, preparing job applications and career planning.

G Verma commented on mental health stigma existing in some cultures. People from some cultures don't reach out for mental health assistance. They don't want to be identified as mentally ill people in their community. D Alurkar stated that privacy and confidentiality could be a factor for some people who may be hesitant to seek mental health support. L Hartley emphasised that Headspace takes confidentiality seriously and ensures a young person's privacy and confidentially is strictly respected. G Verma asked how Headspace would go about stress vs mental health. L Hartley said Headspace doesn't get involved in diagnosis. Referrals will be made to appropriate services such as a medical doctor for diagnosis.

G Verma informed the Committee about the Victorian Interfaith Conference in November 2020 which will be hosted by Melton City Council, Melton Interfaith Network, Wyndham City Council and Wyndham Interfaith Network.

K Khanal introduced the new president Kedar Dulal of Bhutanese Melton Community. He also talked about weekly language school run by their community on Saturdays.
