6.1 Update on Actions from previous meetings

6.2 Reducing Racism in Melton

M Forson, Senior Adviser, the Victorian Equal Opportunity and Human Rights Commission (VEOHRC) talked about VEOHRC and their role.

The VEOHRC is an independent organisation with responsibilities under Victoria's human rights laws. Their role is to protect and promote human rights in Victoria. They work to prevent discrimination and vilification through their education and engagement with communities, employers, government and the Victorian public. When things go wrong or human rights are at risk, they support Victorians to exercise their rights by helping to resolve discrimination complaints and intervening in court cases. They also strive for systemic change by undertaking investigations and independent reviews and advocating for stronger protections and greater respect for human rights and equality.

M Forson talked about the Reducing Racism project which is a three-year project addressing issues of racism in local communities. Initially, phase one of the project focused on Muslim communities and African Australians.

The project has the following aims:

- Empower communities experiencing racism, religious discrimination, and racial and religious vilification to understand and exercise their rights, including reporting instances of racism, discrimination and vilification
- Partner with councils and service providers in identified regions to build organisational capacity in using human rights and equality law to respond to racism



under the Equal Opportunity Act (EOA) and the Racial and Religious Tolerance Act (RRTA)

 Increase people's reporting of racism, discrimination and vilification to the Commission through the development of digital communication strategies and enhancement and expansion of the Community Reporting Tool.

Phase two of the project focuses on broader communities in Melton, Wyndham, Shepparton and Geelong Local Government Areas. One of the components of the project is to conduct a Human Rights Advocates Course. This course will provide more insight and understanding of racism and how to work in this area. M Forson expressed that the Commission would like to run a Human Rights Advocate Course in Melton.

G Verma commented that he has not witnessed racism in Melton but had witnessed many incidents of racism and discrimination online on social media platforms. M Forson advised that online racism matters are beyond the scope of this program, but that VEOHRC can assist by referring groups to the appropriate body for support. She encouraged everyone to use Commission's Community Reporting Tool linked on Melton City Council's website.

E Rider said that Council could share Community Satisfaction Survey results and Community Vision consultation data with the Commission. This could help the Commission understand more about the community in the City of Melton.

M Ali asked about the enforcement of the Federal, State and local Acts with regards to employment and business. M Forson responded that under the Equal Opportunity Act your rights are protected with regards to workplace racism and discrimination.

Action

E Dileri to connect VEOHRC with the Melton Interfaith Network and African Communities Working Group to explore further opportunities to organise a Human Rights Advocate Course in Melton. An invitation will be sent to IAC's Community Service Organisation and Local Intercultural Community representatives.

E Dileri to circulate VEOHRC presentation to all committee members.

E Dileri to forward Community Satisfaction Survey and Community Vision consultation data to the Commission.

6.3 Intercultural Plan and Interfaith Strategy Reporting

E Dileri presented on Intercultural Plan and Interfaith Strategy (the Plans) and informed the Committee on the progress of these strategic documents' final year. The Plans supported Council's vision which is a thriving community where everyone belongs. The Plans provided a roadmap for Council's work in the areas of diversity, interculturalism, inclusion and interfaith. He highlighted several major achievements of the Plans over the past four years. The Plans expire in 2021.

E Rider talked about the new plan which will be developed following the adoption of the new Council and Wellbeing Plan 2021-25. The process will include building on the achievements of the Plans, researching current needs and priorities in the context of the changing community and COVID-19 recovery, building on the consultations of the Council and Wellbeing Plan and Community Vision and targeted community engagement including with the IAC.

6.4 African Communities Working Group (ACWG)

E Dileri briefly talked about the ACWG's meeting held on 22 June 2021 and presented a summary of their discussion.

6.5 Updates from members

Chairperson invited members to provide any updates from their respective communities.

- G Verma mentioned that a festival is being organised by Sri Durga Temple for August. He will send more information about it to IAC members.
- M Ali talked about the Melton Much More App and asked IAC members to promote it in their networks. He also asked whether IAC members could be issued business cards.

Action

E Dileri to investigate the possibility of business cards for IAC members and report back to the Committee.

- M Ali asked whether the frequency of IAC meetings could be increased. E Rider responded that advisory committees are formalised and run on a quarterly basis based on their terms of reference. However, there are many more opportunities for any IAC members to get involved in Council and community networks and initiatives.
- M Tandon talked about a Bollywood dance program which was successful. She is in the processing of organising yoga classes following community requests.
