



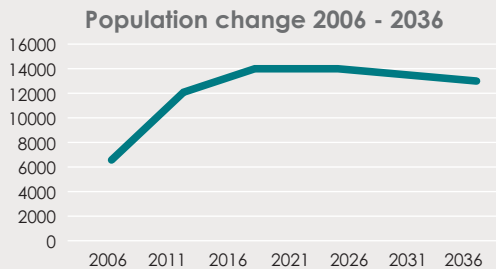
Location & Growth



- > Situated in one of the fastest growing regions in Australia with a population of 13,316
- > Between 2006-2011, the population has increased from 6,835 to 12,034
- > By 2036, the population will decrease to 12,189 (10% decrease)



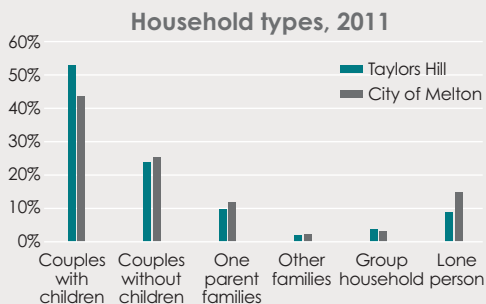
Population



- > Young population, median age is 30 (City of Melton, 32)
- > 227 babies born in 2014 (City of Melton, 2,172)
- > 84% of the population is aged less than 49 years
- > Largest age groups are:
 - 30-34 years old (1,425)
 - 0-4 years old (1,408)
 - 35-39 years old (1,315)



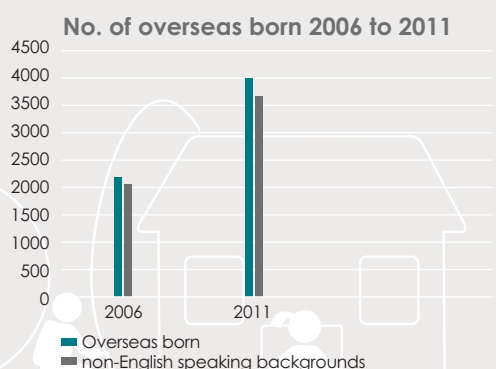
Households



- > There are more than 4,030 households
- > Household composition is:
 - 53% couples with children (City of Melton, 43%)
 - 24% couples without children (City of Melton, 21%)
 - 10% one parent families (City of Melton, 13%)
 - 9% lone persons (City of Melton, 16%)
- > Average children per family is 2



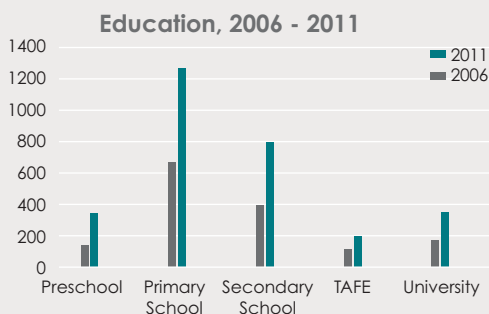
Diversity



- > Between 2006 and 2011, the number of overseas born residents increased from 2,212 to 4,004 (+1,792) which represents 34% of the total population
- > Residents from non-English speaking backgrounds increased by 1,607 to 3,680 (31.3% of the total population)
- > Top three countries of birth: India, the Philippines and Vietnam (9.9% of the total population)
- > 48% of residents speak a language other than English (City of Melton, 29%)
- > Religion:
 - Christianity experienced the greatest change (+3,501)
 - Lower proportion (10%) of no religious affiliation (City of Melton, 17%)
 - Islam and Buddhism is increasing
- > In Taylor's Hill, 18 people identify as being of Aboriginal or Torres Strait Islander background*



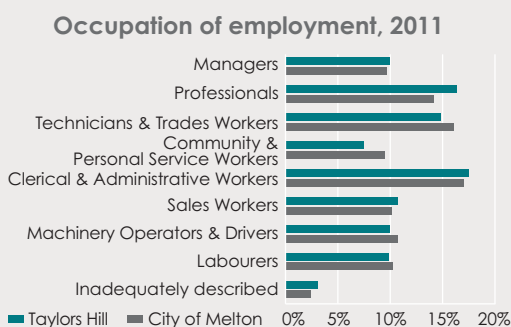
Education



- > 26% of the population attend an educational institution (City of Melton, 24%)
- > There are 1,271 primary schoolers and 803 secondary schoolers
- > 59% of residents have completed Year 12 (City of Melton, 46.5%)
- > 44% held an educational qualification (City of Melton, 41%)
- > University attendance is 3% (City of Melton, 2.8%)
- > Bachelor or Higher Degree qualification is 18% (City of Melton, 13.5%)
- > Vocational qualification is 17% (City of Melton, 20%)



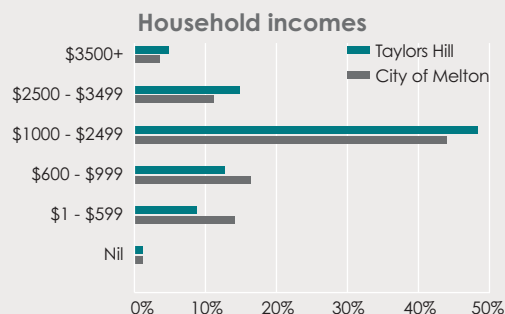
Employment



- > 5,567 of people are employed, of which 67% are working full time and 30% part time
- > Most work in clerical and administrative occupations
- > 17% work in professional occupations (City of Melton, 14%)
- > 74% travel to work by car (City of Melton, 75%)
- > 11% travel to work by train or bus (City of Melton 8%)
- > 10% are engaged in some form of voluntary work



Income



- > 10% of households earn low income (City of Melton, 15%)
- > 19% of households earn high income (City of Melton, 14.5%)
- > Median weekly household income is \$1,654 (City of Melton, \$1,363)
- > Median monthly mortgage repayment is \$2,167 (City of Melton, \$1,733)
- > 26.3% of households are experiencing mortgage stress (City of Melton, 18%)
- > SEIFA index is 1051 (City of Melton 1002)[#]
- > Average motor vehicle per dwelling is 2 (City of Melton, 1.9)
