2. Consultation Summary

The majority of the feedback that was provided supported the proposed upgrade works. Feedback was collected via onsite community consultation and postal survey. Due to the poor weather condition on the day of the Onsite Community Consultation, all feedback was provided by adults and senior residents who:

- supported for the proposed new shelter;
- raised comments about providing more trees and shade in the reserve to extend the time they could stay outside particularly during the summer months:
- focused on easy access and connection for convenience it provided for the community;
- required to provide more park furniture like toilets, bins and seats.

Many commented upon the existing conditions of the site that there were a need for security surveillance, robust design to reduce vandalism and the need for regular maintenance.
