* Enrolling your child into a Melton City Council Kindergarten located on a school site does not automatically guarantee your child's entry into the school the following year.

3 Year old Registrations - completing this registration will also register your child into 4 year old Kindergarten in 2025. This does not guarantee your child a place into the above requested Kindergarten, however it means you will not have to re-apply for 4 year old Kindergarten in 2024. Normal offer processes and timelines will still apply.

Non resident's who have been accepted a placement for their child's 3 year old Kindergarten year in 2024 are not guaranteed a 4 year old placement the following year. Normal non resident process will still apply meaning your application will be reviewed by the Director City Life in November 2024.

Families will be notified of the outcome in late November / early December.

Please note: If you cancel your 3 year old placement prior to commencing then your 4 year old application will also be cancelled. You will then need to re-apply the following year.
