For your nomination to be deemed eligible the following criteria MUST be met:

- 1. Nominees must be a City of Melton resident.
- 2. You cannot nominate yourself, an immediate family member or person that lives with you.
- 3. Nominee must consent to being nominated.
- 4. Nominator or Nominee cannot be a Melton City Council staff member or Councillor.
- 5. Nominee is not performing volunteer work as part of a Centrelink scheme.
